## **Executive Summary**



The Institute for African Women in Law's Gender Scorecard on Women in Law and Leadership presents statistics on the representation of women as Presidents of Bar Associations and Law Societies. Data on women in leadership is crucial for assessing their equitable access to decision-making processes. In several countries across Africa, despite the entry of women into the legal profession in the early to mid-1900s, and the increasing number of women at the bar, women remain underrepresented in the organizations that represent lawyers—the bar associations and law societies.

The legal field has historically been a male-dominated field, with women significantly underrepresented in leadership positions. However, in recent years, many countries have witnessed an increase in the number of women graduating from law schools and a gradual diversification of gender within the legal profession. Nonetheless, women continue to be underrepresented as presidents of bar associations and law societies.

The Institute for African Women in Law has engaged in several advocacy efforts to raise awareness about the underrepresentation of women in leadership positions within the legal profession. Most of these advocacy efforts have taken the form of opinion pieces, such as "Is the Ghana Bar Association Ready for Women Lawyers?", which significantly contributed to the election of the first female bar president of Ghana in 2024. Similarly, in Kenya, through an opinion piece and several social media posts, the article "Is the Law Society of Kenya Ready for Women Leaders?", significantly contributed to the election of the second female president of the Law Society of Kenya in 2024.

In May 2025, IAWL launched a blog series <u>"When Women in Law Lead"</u> to showcase the contributions and impact of women as leaders in bar associations, law societies and leaders of organizations promoting women in law. The Women in Law and Leadership Gender Scorecard represents the first step toward achieving gender equality in leadership positions within the legal field. It will inform future policy interventions aimed at supporting women's advancement in law and leadership.
